

## **Proceedings of the 10<sup>th</sup> Meeting of Hon'ble Oversight Authority held on Dt. 10.08.2023 at 04:00 pm at KMERC, Bengaluru**

The meeting was chaired by Justice B. Sudershan Reddy, Hon'ble Oversight Authority (KMERC).

List of participants is attached as **Annexure-1**.

At the outset, Managing Director (MD), KMERC, Mr. M.P. Guruprasad, welcomed the Hon'ble Oversight Authority, the Additional Chief Secretary & Development Commissioner and other Officers present in the meeting.

MD, KMERC then initiated the meeting as per the Agenda.

### **Agenda 1.**

#### **Confirmation of the Minutes of the 9th Meeting of Hon'ble Oversight Authority held on 7th June 2023**

The minutes of the 9th Meeting of Hon'ble Oversight Authority held on 7th June 2023 were perused and confirmed.

### **Agenda 2.**

#### **Action Taken Report on the decisions of the 9th Meeting of Hon'ble Oversight Authority held on 7th June 2023**

MD, KMERC informed the Hon'ble Oversight Authority that the concerned departments have been communicated regarding approval of the 29 projects of value Rs.742.35 Cr. cleared in the 9<sup>th</sup> Meeting of Hon'ble Oversight Authority held on 7th June 2023, post 15 days of uploading the details of projects in public domain. He mentioned that DPR preparation is in progress in the concerned Departments for the projects approved earlier.

He also informed that no comments/ observations/ suggestions were received from any stakeholders on the approved projects in the said 15 days of uploading the details of projects in the public domain.

Action taken report on the previous meeting proceedings was noted by the Hon'ble Oversight Authority.

### **Agenda 3.**

#### **Projects approved by the Hon'ble Oversight Authority till the 9th Meeting held on 7th June 2023**

MD, KMERC informed that the Hon'ble Oversight Authority has approved a total of 317 development & restoration projects worth Rs.7634.97 Cr. for 31 Different Departments till date, out of the total amount of Rs.24,996.72 Cr. provisioned under CEPMIZ for restoration of mining areas in the Districts of Ballari, Vijayanagar, Chitradurga, and Tumkur.

The same was noted by the Hon'ble Oversight Authority.

### **Agenda Item No. 4**

#### **Sub: Projects deferred by the Hon'ble Oversight Authority till the 9th Meeting held on 7th June 2023**

MD, KMERC informed that, in the 9 meetings held by the Hon'ble Oversight Authority, a total of 43 projects worth Rs.926.58 Cr. proposed by 13 Different Departments were deferred. The reasons for deferral and the status of the above-mentioned deferred projects are provided in Annexure – 2 of the Agenda Note.

The same was noted by the Hon'ble Oversight Authority.

## **Agenda Item No. 5**

### **Sub: Status of DPR preparation and submission to KMERC**

MD, KMERC informed that, till date, KMERC has received 111 DPRs against the total 317 approved projects from various Departments and remaining 206 DPRs are yet to be submitted by these Departments.

He also mentioned that, since the last meeting of the Hon'ble OA held on 07.06.2023, 20 project DPRs were submitted by 4 Departments. Out of these 20 DPRs, 13 project DPRs have been accorded Administrative Approval. With regard to the remaining 7 project DPRs, compliance is being submitted by the respective Departments on the suggestions made by the KMERC Project Appraisal Committee.

Hon'ble OA expressed his disappointment on the large number of DPRs (206 nos.) to be submitted by the concerned Departments and sought to know the reasons for the delay in preparation and submission of the pending DPRs.

Responding to the same, PCCF (FC) mentioned that the DPR preparation for Forestry Proposals under Eco-restoration involves considerable field-work like exhaustive perambulation of forest areas, taking GPS readings, Forest Mensuration activities, etc. The Karnataka Forest Department has submitted 28 DPRs so far and shall be submitting the rest of the 37 DPRs at the earliest.

The Director, Mines & Geology, suggested that DPR preparation can be considered at KMERC level by empanelling Consultancy firms.

The Principal Secretary, School Education & Literacy Department, informed that DPR Templates have been prepared at the Department level and circulated to the District Offices for DPR preparation and suggested that the same model may be followed by other Departments, if suitable. He further suggested that DPR preparation may be outsourced to Nirmithi Kendra, as done by the Department of Women and Child Development.

Deputy Commissioner (DC), Ballari, informed that the DPR-preparation is nearing completion for the projects proposed by the School Education & Literacy Department and approved in the previous meeting of the Hon'ble Oversight Authority. He further mentioned that there are minor delays in site-finalization for construction of new Anganwadi Centres and requested permission to proceed with DPR preparation for construction of new Anganwadi Centres where sites are available/finalized already.

Responding to the same, the Principal Secretary, School Education & Literacy Department suggested that DPR preparation can be initiated for construction of new Anganwadi Centres where sites are available/finalized already and DPR preparation for the rest of the Anganwadi Centres can be initiated as and when their respective sites are finalized.

Representatives of the Minor Irrigation & Groundwater Development Department and the Public Works Department informed that as per their respective Departmental norms, Agencies are being engaged for DPR preparation through Tendering process.

Hon'ble OA expressed concern over the tendering process for preparation of DPRs and the consequent delay.

The ACS & DC and Chairman, KMERC, explained that the progress of DPR preparation was hampered due to the State Assembly Elections held recently and assured that he shall be holding meetings regularly with the respective DCs to review and expedite the DPR preparation at the district level.

The same was noted by the Hon'ble Oversight Authority.

## **Agenda Item No. 6**

### **Sub: Progress of issuance of Administrative Approvals**

MD, KMERC informed that out of 111 DPRs submitted to KMERC till date, administrative approval has been accorded to 76 Project DPRs across 8 sectors for a total project cost of approx. Rs. 1314.49 Cr.

He added that 37 project DPRs were approved across 6 sectors for a total project cost of approx. Rs. 686.67 Cr. before the Model Code of Conduct for Elections took effect in Karnataka and, 39 project DPRs have been approved for projects across 4 sectors for a total project cost of approx. Rs. 627.82 Cr., after the Model Code of Conduct was lifted.

The same was noted by the Hon'ble Oversight Authority.

## **Agenda Item No. 7**

### **Sub: Progress of Project Implementation**

MD, KMERC informed that Tenders have been called for 50 nos. of approved projects for a total cost of approx. Rs. 1004.57 Cr. He further mentioned that Work Orders worth approx. Rs.46.34 Cr. have been issued for 5 projects – 1 project for Development of Infrastructure in ABZP, Kamalapura, Hospete in Vijayanagara district, and 4 projects for Upgradation of Govt. Toolroom and Training Centres (GTTCs) - which had been approved for a total amount of approx. Rs. 92.93 Cr.

MD, KMERC also informed that the ACS – DC has held several meetings with Secretaries to the Government /Heads of Departments (HoDs) and Deputy Commissioners (DCs), for reviewing the status of Implementation and Detailed Project Report (DPR) preparation for approved CEPMIZ Projects and mentioned that the latest such meeting was held on 19.07.2023 at Vidhana Soudha.

It was further mentioned that internal meetings were conducted by the PCCF(HoFF) and PCCF(FC) of the Karnataka Forest Department at Aranya Bhawan, on 26.06.2023 and 06.07.2023 respectively to review the progress of implementation of the Projects for which Administrative Approvals had been issued by KMERC and the status of submission of DPRs for the projects approved by the Hon'ble Oversight Authority.

The same was noted by the Hon'ble Oversight Authority.

## **Agenda Item No. 8**

### **Sub: Consideration of Projects deferred by the Hon'ble Oversight Authority till the 9th Meeting held on 7th June 2023**

The list of 22 deferred projects which are taken up for consideration in this meeting is placed at Annexure – 2.

MD, KMERC informed that 5 nos. of projects proposed by Panchayat Raj Engineering Department (PRED) under Rural Roads Sector and 7 nos. of projects proposed by Agriculture Department under Agriculture & Allied Activities Sector were deferred in the previous meetings chaired by the Hon'ble Oversight Authority owing to lack of representation from the respective Departments, and as such, these projects are being placed again for consideration in this meeting.

As there was no representation from the said Departments in this meeting as well, the Hon'ble Oversight Authority decided to defer the approval for these proposed projects.

Thereafter, MD, KMERC mentioned that the School Education and Literacy Department has submitted revised proposals under Education Sector (10 nos.) in lieu of the Nutrition Component which was deferred in the previous (9th) meeting chaired by the Hon'ble Oversight Authority on 07.06.2023.

Adding to the same, Principal Secretary to the Govt., School Education and Literacy Department, mentioned that the Hon'ble Oversight Authority had earlier approved the components with respect to "Infrastructure (Civil)", "Learning Infrastructure", and "Improving Learning". However, the Nutrition Component proposing Breakfast for students of primary classes (Std 1 to 5) was deferred in the 9th meeting held on 07.06.2023.

He informed that the revised projects for the Nutrition Component submitted now propose providing Supplementary Nutrition Food (SNF) including Fruits, Vegetables, Eggs and Sweets (fresh fruits in the morning for 4 days, in the afternoon along with Mid-Day Meals, Egg for 2 days, Vegetable palya for 2 days and sweet for 1 day) in the form of "**Enhanced Lunch**" for period of 3 years for class 1-10th students of Government schools in 4 mining affected districts, Ballari (Ballari and Sandur Taluk), Vijayanagara (Hospete Taluk), Chitradurga (Chitradurga, Hosadurga, Molakalmuru and Holalkere Taluks) and Tumkuru (Gubbi, Tiptur and Chikkanayakanahalli), at a total cost of Rs.148.99 Cr. The initiative of providing Supplementary Nutrition Food (SNF) helps combat malnutrition and boosts immunity among the students. It also seeks to improve learning abilities, prevent stunted growth, and addresses social issues like child-labour and school dropouts.

He elaborated that the proposed project-proposals envision a comprehensive approach that addresses both health and education, recognizing the interconnectedness of these aspects in the context of mining-affected areas. The success of the project would be measured not only by improved health indicators but also by positive changes in educational outcomes and the social landscape of the mining affected areas.

After due consideration of the submissions of the Principal Secretary to the Govt., School Education and Literacy Department, the above proposal was approved by the Hon'ble Oversight Authority.

## **Agenda Item No. 9**

### **Sub: Engagement of Internal Auditor for KMERC**

MD, KMERC mentioned that it is proposed to appoint a dedicated Internal Auditor for systematic scrutiny of books of accounts of KMERC and the Project Implementing Departments/ Govt. Agencies.

PCCF(FC) suggested that the agencies already empaneled by the Government for this purpose can be considered.

The Commissioner, Sericulture Department, added that Concurrent Audit can also be considered by engaging retired Government Auditors whose panel is available with the Office of the Comptroller and Auditor General (CAG).

After due consideration of the above suggestions, the Hon'ble Oversight Authority opined that a detailed note on the above may be prepared to facilitate a decision on the matter.

## **Agenda Item No. 10**

### **Sub: Update on KMERC's Financial Management**

MD, KMERC informed that as on 31.07.2023, the Monitoring Committee has totally transferred Rs. 23,790.90 Cr.

Hon'ble Oversight Authority noted the details of fund-investments in RBI Treasury Bills and project/administration related expenditure furnished in the Agenda Note.

The Meeting concluded with vote of thanks to the Chair and all the Officers present.
